**Scoring Objective** - One of the most frequent questions asked of this program is why a certain amount of points are awarded for one scored area and a different amount of points to other areas. The Chapter of the Year Program is divided into four major areas. They are General Chapter, Membership Enhancement, Rider Education and Leadership Training. One of the internal goals of developing and updating the score sheet each year is to ensure that the points for these four major areas remain fairly equal. By doing this, Chapters that are stronger in Rider Education do not have an unfair advantage over Chapters that might not be so strong in Rider Education. The same example can be used for Chapters that are stronger in Membership Enhancement or Leadership Training. Keeping all four of the major scored areas equal help meet the program's goal by ensuring that small as well as large Chapters have an equal opportunity to win and be recognized as the best Chapter in all of GWRRA. In this 2013 Chapter of the Year Program each of these major four areas have a possible score of 75 points each making the total possible points for the 2013 program to be 300 points.

## **GWRRA Chapter of the Year History**

The Chapter of the Year Program was created and designed in 2007 to stimulate Chapters to strive for excellence within their respective District and Region. Secondly it is to find and recognize the best of the best Chapters within GWRRA.

## **GWRRA Chapter of the Year Goal**

The goal of the Chapter of the Year Program is to get more Chapters involved in all of the GWRRA programs and **FUN** activities that have been proven successful for many of the active and growing Chapters throughout GWRRA. Chapters that enter into the Chapter of the Year Program and are not selected as the District, Region or GWRRA International Chapter of the Year, will be a stronger healthier Chapter for their efforts. Many of the scoring areas are measured in percentages to ensure that small and large Chapters alike have an equal chance in winning.

## **Disqualifier**

If a Chapter was selected as the 2012 District Chapter of the Year they cannot be selected as the 2013 Chapter of the Year. A 2012 District Chapter of the Year must wait one year to compete in this program again. All Chapters, including the 2012 District Chapter of the Year can participate in the Gold, Silver, Bronze part of this program, if the District elects to participate in this part of the Chapter of the Year Program.

## **2013 Chapter of the Year Program Guide**

### **Basics for 2013 - 1 Point for each (Maximum 5 Points)**

Does the Chapter have an Assistant Chapter Director?

Does the Chapter have a Chapter Educator?

Does the Chapter provide a Newsletter to all Chapter Participants free of charge on a monthly basis?

Does the Chapter meet monthly at an appropriate location to promote GWRRA's motto, "Friends for FUN, Safety, and Knowledge"?

Was the Chapter's Annual Financial Report for the previous year correctly submitted on time to the District Director?

### **A Little Extra for 2013 - 1 Point for each (Maximum 21 Points)**

Does the Chapter have a Chapter Mascot?

Does the Chapter have a Chapter Banner?

Does the Chapter have an up to date and current Chapter Scrap Book?

Did at least 30% of the Chapter Participants attend a District Convention outside their District but within their own Region? (1 Point for each Convention attended up to a maximum of 3 Points.)

Did at least 25% of the Chapter Participants attend their Region Convention?

Did at least 20% of the Chapter Participants attend a Convention outside their Region? (1 Point for each Convention attended outside their Region up to a maximum of 3 Points.)

Did at least 15% of the Chapter Participants attend Wing Ding in 2013?

**To calculate the average number of Chapter Participants...**collect all of the 2013 Chapter Monthly Gathering Sign In Sheets and determine average number of Chapter Participants as of December 31, 2013. Visitors should not be a part of the average Chapter Participants. A guideline is to count regular Chapter Participants as those Chapter Participants that attend at least 50% of the Chapter's monthly Gatherings.

### **The same person cannot be counted more than one time for attending a Chapter of the Year seminar or OCP.**

Did the CD attend a Chapter of the Year Seminar between July1, 2012 - December 31, 2013?

Did the ACD attend a Chapter of the Year Seminar between July1, 2012 - December 31, 2013?

Did the Chapter of the Year Coordinator attend a Chapter of the Year Seminar between July1, 2012 - December 31, 2013?

Did the Chapter MEC attend a Chapter of the Year Seminar between July1, 2012 - December 31, 2013?

Is the ACD current in the Officer Certification Program?

Is the Chapter Educator current in the Officer Certification Program?

Is the Chapter Treasurer current in the Officer Certification Program?

Is the Chapter Membership Enhancement Coordinator current in the Officer Certification Program?

Is the Chapter of the Year Coordinator current in the Officer Certification Program?

Is the Motorist Awareness Coordinator current in the Officer Certification Program?

### **Bonus Points for 2013 - 4 Points for each (Maximum 12 Points)**

Does the Chapter have a Membership Enhancement Coordinator?

Does the Chapter have a Chapter of the Year Coordinator?

Does the Chapter have a Motorist Awareness Coordinator?

### **District Convention Support - 8 Points**

Did at least 35% of the Chapter Participants attend their own District Convention?

**Event/Ride Schedule**

The Chapter prepares an event/ride schedule each month and provides a copy to all Chapter Participants and the District Chapter of the Year Coordinator. The purpose of the monthly submissions is to ensure that upcoming events and rides are made available to all Participants each month. Impromptu rides should be added to the Event/Ride Schedule and the updated Event/Ride Schedule should be submitted to the District Chapter of the Year Coordinator with the final submission packet. The final Chapter of the Year packet should include a copy of each monthly schedule (monthly or revised). Although a Chapter can begin participation in the Chapter of the Year Program at any time during the year, those Chapters that begin in January will be eligible for more points than those beginning later in the year.

For example, if a Chapter starts sending their monthly Event/Ride Schedule in January and they have 3 or more rides per month they would get 2 points for January, 2 points for February, 2 points for March, etc... If a Chapter starts sending their event/ride schedule in May, May is the first month that the Chapter can start receiving points in this category. The Chapter Event/Ride Schedule must be forwarded to all levels for verification of points in this category.

Point Value.....1 - 2 monthly events.....1 Point per mo  
Point Value.....3 or more monthly events....2 Points per mo  
You either get 1 point for the month or 2 points for the month. Do not combine them.  
**Maximum of 24 Points**

**Extraordinary Chapter Events or Activities**

List the outstanding and Extraordinary Chapter Events or Activities that the Chapter hosted or participated in during 2013.

Examples; Charitable rides or donations, Chapter awards received during the year, Guest speakers at Chapter Gatherings, Campouts, Festive parties, Bike Shows, Toy Rides, Parades, Adopt a Family program, Cruise-in's, visiting another GWRRA Chapter, etc... Don't be modest, toot your own horn. All Extraordinary Activities must appear on your Event/Ride Schedule to count. A minimum of 25% of the average number Chapter Participants must participate in the Extraordinary Event for it to count in this category. Extraordinary Chapter events or activities listed in this category may not be listed or counted in the Planned Chapter Recruiting or Motorist Awareness Activities section.

Must have a minimum of 25% of average number of Chapter Participants taking part in each event/activity to count. **Maximum 15 Points, 1 Point each**

**Membership Enhancement Program**

**Area Report Lists**

Did the Chapter contact all New and Prospective GWRRA Members when they appeared on the Monthly Area Report List (ARL)? 1 Point for each month if all were contacted. Count 1 point for months that your Chapter did not have any New or Prospective Members.

## **Planned Chapter Recruiting Activities**

List the date, describe each activity and what was done to recruit and record the number of Chapter Participants attending the Recruiting Activity. These Recruiting activities must be listed on the Event/Ride Schedule.

Example: 03/25/2013 - GWRRA Recruiting Table at Northgate Mall where we displayed our Gold Wings, passed out GWRRA literature and solicited new memberships. 15 Chapter Participants.

A minimum of 25% of the Chapter must participate in each planned Chapter Recruiting Activity for it to count in this category. Planned Chapter Recruiting Activities listed in this category may not be listed or counted in the Extraordinary Chapter Events or Activities. Extraordinary Chapter events or activities listed in this category may not be listed or counted in the Planned Chapter Recruiting or Motorist Awareness Activities or the Motorist Awareness sections. **Maximum of 15 Points, 1 Point per Recruiting Activity**

## **Retention**

Chapter has a written action plan for the purpose of retaining existing Chapter Participants. Be sure to include any and all retention activities that the Chapter Team and/or Chapter Participants are doing to retain Members. Please note that this should be very specific to what the Chapter is doing to "RETAIN" current GWRRA Members. This is not a recruiting plan. **5 Points**

## **Written Plan to Bring Back Members with Expired Memberships**

Chapter has a written action plan for the purpose of bringing back past GWRRA Members whose memberships have expired. Be sure to include anything that the Chapter Team and/or Chapter Participants are doing to encourage these Members to rejoin GWRRA. To score any points for this category the Chapter must provide the names of at least two GWRRA members whose memberships had expired for more than three months and then renewed their memberships with GWRRA. **5 Points**

## **Chapter Web Site (Maximum of 5 Points)**

Chapters that have a web site and the following items are on the home/first page will be scored as follows:

- The GWRRA logo and the words "Gold Wing Road Riders Association" or the acronym "GWRRA". **1 Point**
- Region, District, Chapter designations, plus city and state will serve to identify the webpage for those visiting the site. **1 Point**
- A link to the International, Region, and District web site. **1 Point**
- Monthly Gathering meeting place and time on the web site. **1 Point**
- The Chapter Director's Name and phone number or Name and link to e-mail address on the web site. **1 Point**

## **Chapter Couple of the Year**

The Chapter selects a Chapter Couple of the Year for 2013 in accordance with the Couple of the Year Manual. Maximum 16 Points.

- Chapter selects a Chapter Couple of the Year - **6 Points**
- Chapter Couple of the Year participates in the District Selection Process - **10 Points**



## **Membership Enhancement Seminars**

Does your Chapter participate in GWRRA Membership Enhancement Seminars? 1 point for each Seminar. A minimum of 25% of average number of Chapter Participants must attend each seminar to count. **Maximum 7 Points.**

75.5 - 100% of Chapter Participants in Levels Program	16 Points

Participants must be current in their level to count.

### **Chapter Rider Educator's Quarterly Reports**

Did the Chapter prepare and submit the quarterly N.6 report to the District Educator? 3 points for each quarter the N.6 report was prepared and submitted on time. 1<sup>st</sup> Quarterly Report for period 01/01/2013 - 03/31/2013. 2<sup>nd</sup> Quarterly Report for period 04/01/2013 - 06/30/2013. 3<sup>rd</sup> Quarterly Report for period 07/01/2013 - 09/30/2013. 4<sup>th</sup> Quarterly Report for period 10/01/2013 - 12/31/2013. Submit all four quarterly reports with the Chapter of the Year packet. **Maximum 12 Points.**

### **Rider Education - Seminars**

Does your Chapter participate in GWRRA Rider Education Seminars? 1 point for each Seminar. A minimum of 25% of average number of Chapter Participants must attend each seminar to count. **Maximum 16 Points.**

### **Rider Education - Parking Lot Practice (PLP)**

The Chapter participates in a Parking Lot Practice (PLP) exercise in 2013. A minimum of 25% of the Chapter must participate in the PLP for it to count in this category. A list of Participants must be submitted with the packet and forwarded to all levels. This list no longer requires the signature of the PLP facilitator. **5 Points per PLP with a maximum of 2 per year or 10 Points**

### **Chapter Motorist Awareness Coordinator's Quarterly Reports**

Did the Chapter prepare and submit the quarterly N.23 report to the District? 3 Points for each quarter the N.23 report was prepared and submitted on time. 1<sup>st</sup> Quarterly Report for period 01/01/2013 - 03/31/2013. 2<sup>nd</sup> Quarterly Report for period 04/01/2013 - 06/30/2013. 3<sup>rd</sup> Quarterly Report for period 07/01/2013 - 09/30/2013. 4<sup>th</sup> Quarterly Report for period 10/01/2013 12/31/2013. Submit all four quarterly reports with the Chapter of the Year packet. Submit all four quarterly reports with the Chapter of the Year packet. **Maximum of 12 points.**

### **Rider Education - Motorist Awareness Events**

Chapter will receive 2 points for each Motorist Awareness Event that they organize and conduct. These events can be for either a motorcycle group outside your home Chapter or non-motorcycle group. A copy of the sign in sheet must be prepared and submitted with Chapter of the Year Package. Each roster will include date of the event, the name of the event, the number of attendees and the number of Chapter Participants that were an active part of the event. Motorist Awareness Events listed in this category may not be listed or counted in the Planned Chapter Recruiting Events or Extraordinary Chapter Events sections. – **Maximum of 6 Points**

### **Rider Education - Motorist Awareness Seminars**

Does your Chapter participate in GWRRA Motorist Awareness Seminars? 1 point for each Seminar. A minimum of 25% of average number of Chapter Participants must attend each seminar to count. **Maximum of 3 Points.**

## **Leadership Training Program**

### **Chapter Director (CD) & Assistant Chapter Director (ACD) Leadership Training**

This category will score the total amount of Leadership Training Programs (Member Orientation [8 Seminars], Life Skills [8 Seminars], Chapter Life [6 Seminars], Leadership Skills [8 Seminars], Intermediate Skills [9 Seminars], Advanced Skills [8 Seminars] and Horizon Program completed at any time before December 31, 2013 by the Chapter Director and/or the Assistant Chapter Director. Completion Certificate and/or copy of the Leadership Training Record must be submitted as a part of Chapter packet to all levels for verification of points in this category. **1 Point for each program completed Maximum of 14 Points**

### **Chapter Leadership Training Program (LTP) Training**

The Chapter will earn 1 point for each Leadership Training Seminar attended from the Membership Orientation, Life Skills, Chapter Life, Leadership Skills, Intermediate Skills or Advanced Skills. These seminars will count whether taken at a home Chapter or GWRRA event. A minimum of 25% of the Chapter must participate in LTP Seminar for it to count in this category. Points in this category can only be counted if Chapter Participants completed these seminars during Calendar Year 2013. Keep attendance rosters as proof of this Chapter LTP Training and turn in with the Chapter of the Year packet. The Chapter LTP Training Attendance Roster must be forwarded to all levels for verification of points in this category. **Maximum of 47 Points.** Attendance Rosters must include:

- Date of Seminar
- Name of Seminar
- Seminar Instructor
- Names of Participants

**1 Point for each individual Seminar**

### **Chapter Leadership Training Program (LTP) Horizon**

The Chapter will earn 14 points if 35% of the Chapter Participants complete the Horizon Program any time before December 31, 2013. Individual Horizon Completion Certificates should be submitted with Chapter of the Year Packet for verification of points in this category. **14 Points**

### **Chapter Level Responsibilities**

- Prepare the Chapter of the Year packet which should include:
  - Completed Chapter of the Year Score Sheet
  - All Event/Ride Schedules
  - All PLP Rosters
  - All RE Seminar Rosters
  - All Quarterly Chapter N.6 Reports

  - All Quarterly Chapter N.23 Reports
  - All Chapter LTP Seminar Rosters
  - Horizon Completion Certificates for Chapter Participants
  - All CD LTP Training Records

  - List of participants that attended each District Convention
  - List of participants that attended each Region Convention
  - List of participants that attended Wing Ding
  - All Chapter Monthly Gathering Sign-In Sheets to the District Level Only
- Determine the average number of Chapter Participants as of December 31, 2013. Visitors should not be a part of the average Chapter Participants. A guideline to determine average number of chapter participants is to count regular Chapter Participants as those Chapter Participants that attend at least 50% of the Chapter's monthly Gatherings.

Submit **hard copy** of packet to District Chapter of the Year Coordinator on or before February 1, 2014.

## **District Level Responsibilities**

- Designate someone as the District Chapter of the Year Coordinator
- Coordinate with other District Team Members & verify All Score Sheet data. This includes collecting all the 2013 Chapter Monthly Gathering Sign In Sheets from all participating Chapters to verify the average number of Chapter Participants as of December 31, 2013. Visitors should not be a part of the average Chapter Participants. A guideline is to count regular Chapter Participants as those Chapter Participants that attend at least 50% of the Chapter's monthly Gatherings. The final determination of average number of Chapter Participants will be up to the District Director. The Chapter Monthly Gathering Sign-In Sheets do not have to be forwarded to Region.
- Complete the "Verified By" Section of the Score Sheet
  - Enter the average Number of Chapter Participants as of December 31, 2013
  - Ensure the CD has completed the entire score sheet including the "Submitted By" Section
  - Sign and Date the "Verified By" Section
- Ensure the winning packet forwarded to Region includes:
  - Completed Chapter of the Year Score Sheet
  - All Event/Ride Schedules
  - All PLP Rosters
  - All RE Seminar Rosters
  - All Quarterly Chapter N.6 Reports
  - All Motorist Awareness Seminar Sign In Sheets

- Select and recognize a District Chapter of the Year
- Recognize other Chapters that participated in the Chapter of the Year Program
- It is suggested that each District recognize all Chapters that participate in the Chapter of the Year Program by the following designation which can be determined according to the number of total points earned.
  - Gold Level Chapters.....225 & > Points (75%) and higher
  - Silver Level Chapters.....150 to 224 Points (50-75%)
  - Bronze Level Chapters..... 75 to 149 Points (25-50%)

(A Chapter of the Year will be named based on total points earned, regardless of what "level" they attain.)

- District Director completes the "Approved By" Section of the Score Sheet
- Forward hard copy of the winning District Chapter of the Year packet (only one winner/packet per District) to the Region Chapter of the Year Coordinator on or before March 1, 2014. The packet should include everything listed above in the District section except the Chapter Sign-In Sheets.

## **Region Level Responsibilities**

- Designate someone as the Region Chapter of the Year Coordinator
- Select and recognize a Region Chapter of the Year
- Forward hard copy of the winning Region Chapter of the Year packet (only one winner/packet per Region) to the International Assistant Director, Chapter of the Year Program on or before April 1, 2014.

- The packet should include everything sent from the District.
- Ensure that the District has completed all requirements as listed above.
- Ensure the winning packet forwarded to GWRRA includes:
  - Completed Score Sheet
  - All Event/Ride Schedules
  - All PLP Rosters
  - All RE Seminar Rosters
  - All Quarterly Chapter N.6 Reports
  - All Motorist Awareness Seminar Sign In Sheets
